Admission Notice for Admission to Direct Second Year of Four Year Full time Degree Courses in Engineering/Technology 2016-17

In exercise of the powers conferred by section 23 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2016), the Government of Maharashtra has notified the rules 'the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions to the Full Time Professional Undergraduate Technical Courses) Rules, 2016' to regulate the admissions to the First and Direct Second Year of Full Time Professional Undergraduate Technical Courses (Engineering and Technology, Pharmacy, Pharm D., Architecture, Hotel Management and Catering Technology). These rules are also applicable for admissions in Government and Government Aided institutions vide Government Resolution of Higher & Technical Education Department No. TEM-2016/CR 536/TE-4 Dated 15th March 2016.

This notification is being issued for Online Registration, Documents Verification and Application Form Confirmation at Facilitation Centers (FC) by candidates aspiring for admission to Direct Second Year of Four Year Full time Degree Courses in Engineering/Technology in the Government, Government Aided, University Managed, University Departments and Unaided Private Professional Educational Institutions for the Academic Year 2016-17 in the Maharashtra State. The Director, Technical Education shall act as a Nodal Officer to carry out the admissions under the supervision & control of the Competent Authority.

Eligibility for admission for Maharashtra State & All India Candidates

- (i) The Candidate should be an Indian National;
- (ii) Passed Diploma Course in Engineering and Technology with at least 45% marks (40% marks in case of candidates of Backward class categories and Persons with Disability belonging to Maharashtra State only) in appropriate branch of Engineering and Technology from an All India Council for Technical Education or Central or State Government approved Institution or its equivalent; **OR**
- (iii) Passed B.Sc. Degree from a University Grants Commission (UGC) or Association of Indian Universities recognized University with at least 45% marks (40% in case of candidates of Backward class categories and Persons with Disability belonging to Maharashtra State only) and passed HSC with Mathematics as a subject Provided that students belonging to this category shall clear the subjects of Engineering Graphics/ Engineering Drawing and Engineering Mechanics of the first year Engineering Program along with second year subjects.

Important Note:-

1. All types of candidates including minorities aspiring for admission under CAP seats, it is **mandatory** to get registered and get Documents Verified and Confirmed at Facilitation Center.
2. As per the Rule No 3 & 13 of the notified rules, candidates aspiring for admission for Institutional Quota, vacant seats after CAP, it is a **prerequisite & mandatory** to get documents verified and confirmed at facilitation centers.
3. Only those Candidates who have verified and confirmed documents at Facilitation Centers and having CAP Merit number shall be eligible for admission for all types of seats/quota.

Online Registration for Admission:- Availability of the Application Kit and Mode of Payment

- 1.1 It is mandatory for the aspiring candidates to purchase Application Kit from any Facilitation Center (FC) against the payment of Rs. 500/- in CASH for General Category & Outside Maharashtra State (OMS) candidates [Rs. 400/- for Reserved Category & Persons with Disability Candidates belonging to Maharashtra State only]. This fee is non-refundable and non-transferable under any circumstances.

1.2 The Application Kit consists of Application ID and Password, by which the candidate shall be able to fill the Online Application Form. It is necessary to get application kit online activated at FC from where it is purchased.

1.3 The candidates should apply online on <http://dse16.dtemaharashtra.org/dse16> as per schedule

Important Instructions for candidate:

1. The List of the institutes identified as Facilitation Centers (FC) is available on the website.
2. The Information Brochure shall be given to the candidate on producing original Diploma/Degree Mark sheet at FC where the candidates have verified & confirmed the application.
3. The candidates are required to produce the documents in original for verification and Confirmation of Application Form at FC.
4. Candidates are advised to keep the necessary documents ready and scan/upload all the documents.
5. If candidates fail to confirm online filled Application Form at FC, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for both CAP as well as non CAP process.
6. The candidates belonging to SC, VJ/DT (NT (A), NT (B), NT(C), NT (D), OBC and SBC categories should produce "Caste Validity Certificate" issued by Scrutiny Committee of Social Welfare Department and the Candidate belonging to ST category should submit "Tribe Validity Certificate" issued by Scrutiny Committee of Tribal Department. All Backward Class candidates excluding SC & ST should produce Non Creamy Layer certificate valid up to 31st March 2017 at the time of verification of documents at FC, if these candidates are not able to produce the Non Creamy Layer certificate, then such candidates will be treated as GENERAL category candidates and such candidates will not be able to claim Reserved seats in the admission process.
7. Reserved category candidates unable to produce Caste/Tribe Validity Certificate are required produce Proforma H on Rs.100/- Non Judicial Bond Paper for verification.
8. Candidates who have registered as a reserved category candidate but unable to produce required documents for reservation claim during documents verification, shall have to pay difference amount of fees of ₹ 100/- at the FC in cash.

General Notes:

1. Candidate can avail the facilities for filling online application form, scanning documents free of cost at Facilitation Centre (FC).
2. All FC's shall remain open on all days including holidays and Sundays for submission & confirmation of application form during the schedule.
